Purpose or nature of meeting: Public Rally for Immigration Reform

Said organization to be governed by the rules set forth by the Lexington Fayette Urban County Government Division of Parks and Recreation.

1. Permit is ONLY for the time stated on this special permit. Please do not expect to use facility before or after the time stated on permit, and all people in group must leave by the time permit expires. (Charges and staff work schedules are based on hour of permits).
2. Permit is granted on condition that if facility is needed for Parks and Recreation function, grantee agrees to forgo use of facility, with advance notice.
3. Intoxicated persons and/or alcohol are not permitted on premises, except as outlined on separate alcohol permit.
4. No money or tickets can be exchanged or collected on premises, and permits shall not be used for any charitable venture which will be accepting donations on the premises.
5. Parties such as anniversary, reception, etc., and the exchange of gifts that are a natural part of party, will be permitted.
6. Permit is for a specific space (not entire building) with chairs and/or tables, (for inside only), and does not include supplies, equipment, table coverings, firewood, etc.
7. The permit holder shall release, absolve, indemnify, save and hold harmless, the Lexington Fayette Urban County Government, the Division of Parks and Recreation, and their agents and employees, from and against liability, claims, and demands on account of personal injuries (including, without limitation to the foregoing, workmen's compensation and death claims) or property loss or damage loss or damage of any kind whatsoever, to the permit holder or any individual(s) who is injured at the function for which the facility is being used, which arise out of or be in any manner connected with the performance of this contract, regardless of whether such injury, loss, or damage shall be caused by, or be claimed to be caused by, the negligence of the permit holder or of the Lexington-Fayette Urban County Government, the Division of Parks and Recreation, or by any of their agents or employees, or by accident or otherwise.
8. The permit holder shall surrender possession of all said premises and all parts thereof to the Division of Parks & Recreation in good condition as said premises were when first occupied by the permit holder.
9. Person obtaining permit (21 years or older) is responsible for group's conduct and respect for facility. Any groups who abuse the facility or violates rules and regulations will not be issued any future permits, and charges for damages will be assessed.
10. There will be a MINIMUM charge of \$50.00 or 25% of total amount if cancelled within 30 days of event.
11. Applicant submits that this event is family oriented, non-commercial and that no sales will take place.
12. All LFUCG buildings are non-smoking facilities and all food & beverages must be consumed indoors.

Special requirements One electrician to electrify showmobile and be on site during event. Two Park Patrol officers from noon to 7:00 PM. 10 Tables and 40 chairs delivered, one golf cart from Jacobson Maintenance Showmobile operator on site for event. Need 8-10 trash barrels and one maintenance person to assist with crowd control and trash pickup. Rudy Cruse will be in charge for Parks
